#### What are the most common federal funds and how can I use them?

The federal funding landscape can be daunting to navigate. #### Key Things to Note for the Elementary and Secondary School Emergency Relief (ESSER) Funds:

Funds from the various federal relief packages (CARES, CRRSA, ARP) may be used for a wide range of activities to address needs arising from the COVID-19 pandemic, including any activity authorized above by the ESEA, the IDEA, or Perkins CTE. Here are a few additional things to keep in mind as you are planning how you will be utilizing ESSER funds.

#### Allocating 20% of ARP ESSER Funds to Learning Loss

An important thing to note as you are in your planning process, especially when you are using the American Rescue Plan Elementary and Secondary School Emergency Relief (ARP ESSER) Fund, is that local education agencies (LEAs) must allocate at least 20 percent of their funds to address student learning loss. As well, state education agencies (SEAs) are required to reserve their allocations to carry out activities: 5 percent to address learning loss, 1 percent for afterschool programs, and 1 percent for summer learning programs. Remaining LEA funds may be used for a wide range of activities to address needs arising from the coronavirus pandemic, including any activity authorized by the Elementary and Secondary Education Act (ESEA), the Individuals with Disabilities Education Act (IDEA), the Adult Education and Family Literacy Act (AEFLA), or the Carl D. Perkins Career and Technical Education Act of 2006 (Perkins CTE).

#### **Stakeholder Engagement**

LEAs will be required to seek broad public input and develop their own plans for the use of ARP ESSER funds. This is in addition to the statutory requirement in the American Rescue Plan that school districts develop a plan for the safe return to in-person instruction and continuity of services.





# Appendix: Definitions of federal funds

#### Title I, Part A // Significant Funding Flexibility

This supports activities to help improve education for disadvantaged students. Funds are allocated to states and then to districts by specific formulas and are allocated through four statutory formulas based primarily on census poverty estimates and the cost of education in each state. It provides financial assistance to local educational agencies (LEAs) and schools with high numbers or high percentages of children from low-income families. Roughly 80 percent of Title I schools operate schoolwide programs, while the remaining schools operate "targeted assistance" programs. If a Title I school is operating a targeted assistance program, the school provides Title I services to children who are failing, or most at risk of failing, to meet challenging academic standards. The program serves an estimated 25 million students in nearly 90 percent of school districts and nearly 60 percent of all public schools.

#### Title II // Moderate Funding Flexibility

This supports the professional development of teachers and school leaders (e.g., principals). States can use these funds for a variety of activities, including reforming of teacher and school leader certification and licensing; helping LEAs design and implement teacher school leader evaluation and support systems that are based in part on evidence of student academic achievement; improving equitable access to effective teachers; creating or improving alternative routes to certification; providing technical assistance to LEAs; improving professional development; improving state reciprocity of teacher and principal certification or licensing; reforming or improving teacher and principal preparation programs; and training teachers on the appropriate use of student data. LEAs may use funds to develop, implement, and evaluate comprehensive programs and activities to improve teacher and school leader effectiveness, including developing evaluation and support systems; implementing initiatives to assist in recruiting, hiring, and retaining effective teachers, especially in low-income schools; promoting teacher leadership; recruiting qualified individuals from other fields; reducing class size; providing high-quality, personalized professional development; and developing feedback mechanisms to improve school working conditions. In 2015–16, two-thirds of LEAs reported using at least a portion of their Title II, Part A funds for professional development activities for teachers and paraprofessionals, and just over one-third of LEAs used funds to reduce class size.

#### Title III // Moderate Funding Flexibility

This supports academic attainment of English learners (ELs) and helps students get up to speed, including immigrant students. The program supports formula grants to states based on each state's share of the nation's EL and recent immigrant students, with 80 percent of allocations based on state shares of ELs and 20 percent based on state shares of recent immigrant students. LEAs must use funds for developing and implementing new language and academic content programs for ELs and immigrant students; carrying out innovative, locally designed activities that improve or expand existing programs for ELs and immigrant students; or implementing schoolwide or LEA-wide reforms to language and academic content programs.

## Title IV, Part A (Student Support and Academic Enrichment Grants) // Significant Funding Flexibility

This supports increasing the capacity of SEAs and LEAs to provide a well-rounded education, improve conditions for student learning, and improve the use of technology. Funds are allocated to states by formula based on each state's share of funds received under Title I, Part A of ESSA. LEAs may use funds for a range of activities, including providing mentoring and school counseling; increasing the availability of accelerated learning courses, school-based mental health services, and technology to support personalized learning; improving instruction; and building technology capacity.

# Title IV, Part B (21st Century Community Learning Centers) // Limited Funding Flexibility

This supports activities provided during nonschool hours that offer learning opportunities for school-aged children. In addition, the community learning centers may offer training in parenting skills and family literacy services. Centers must target their services primarily to students who attend schools identified for improvement under Title I. Program funds may be used for a broad range of activities, such as those that support a well-rounded education, financial literacy programs, services for individuals with disabilities, activities for students who are English learners, cultural programs, and technology education programs. Funds may also support in-school activities as part of an expanded learning time program under which the regular school day has been extended to include at least 300 additional program hours. The program currently provides funding to 10,200 centers serving 2.1 million students and 349,000 adults and family members.

Title V, Part B (Rural Education Initiative) // Significant Funding Flexibility This supports rural and low-income schools. The rural education program includes two distinct programs to assists rural LEAs to improve the quality of teaching and learning in their schools. One program provides funds to rural LEAs that service small numbers of students, and the other provides funds to rural LEAs that service a high concentration of students living in poverty, regardless of the LEA's size. LEAs may use funds to carry out activities otherwise allowed under other ESSA Title programs.

#### IDEA // Moderate Funding Flexibility

This provides federal funding for the education of children with disabilities. Part B provides federal funding to states and requires, as a condition for the receipt of such funds, the provision of a "free appropriate public education" (FAPE) to children with disabilities between the ages of 3 and 21. Each child receiving services must have an Individualized Education Program (IEP) delineating the specific special education and related services to be provided to meet his or her needs.

# Strengthening Career and Technical Education for the 21st Century Act (Perkins V) // Moderate Funding Flexibility

This provides funds to states to expand and improve career and technical education in high schools, technical schools, and community colleges. Each state uses program funds to support a variety of career and technical education programs developed in accordance with its state plan.

#### CARES Act / ESSER I // Significant Funding Flexibility

On March 27, 2020, the Coronavirus Aid, Relief, and Economic Security Act (CARES Act) was signed into law. Congress set aside approximately \$13.2 billion of the \$30.75 billion allotted to the Education Stabilization Fund (ESF) through the CARES Act for the Elementary and Secondary School Emergency Relief Fund (ESSER Fund) for the purpose of providing LEAs with emergency relief funds to address the impact of COVID-19.

#### CRRSA Act / ESSER II // Significant Funding Flexibility

On December 27, 2020, the Coronavirus Response and Relief Supplemental Appropriations Act, 2021 (CRRSA), was signed into law. The law includes \$54.3 billion for the Elementary and Secondary School Emergency Relief Fund (ESSER II Fund).

America Rescue Plan / ARP ESSER // Significant Funding Flexibility On March 11, 2021, the American Rescue Plan (ARP) Act was signed into law. The act includes \$122.8 billion for the ARP Elementary and Secondary School Emergency Relief (ARP ESSER) Fund to help safely reopen and sustain the safe operation of schools and address the impact of the coronavirus pandemic on the nation's students.
